This class has been approved and is designed to **renew a MN Certified Food Protection Manager Certification (every 3 years). Testing is not required to renew the MDH Food Protection Manager Certification.**

Note:

If you choose to be ServSafe® Certified, you will need to take the ServSafe® exam (every 5 years). The ServSafe® exam will be administered at the end of the day on April 21, 2020.

If you choose to attend the full certification course, a different registration form is necessary. The registration fee is \$160.00 per person prime vendor or \$200.00 non-prime vendor with Sysco ND.

Pre-Registration is required:

Registration and non-refundable payment required by March 23, 2020.

Fees are non-refundable for the book and/or course.
