LeeAnn Thiel shared that they have begun the data analysis with Myers and Stauffer. She is certain they will be using the nursing component of the PDPM however, is still determining whether they will also use the therapy components. She states the NTA component will likely not be chosen since she isn't sure how that would be implemented.

The group provided feedback on their concerns and requested items to make a smoother transition such as a template letter to explain the transition to long term residents, updating the resident/family booklet, creating guidelines documents, a statement at the bottom of the rate letters so residents are aware of the transition, and training opportunities for staff. We look forward to the next workgroup meeting to continue collaboration.

# Improve Your Person-Centered Care for SNF Short-Stay Patients

SNF

AHCA/NCAL offers a four-module webinar to train staff about the delivery of person-centered care under the Patient Driven Payment Model (PDPM). Person Centered Care in a PDPM World is built to train senior staff about delivering short-stay post-acute person-centered care and position them to then train other facility staff.

The cost of this program is \$150 AHCA members and \$300 for non-members. Individuals can <u>register for this course</u> with their AHCA/NCAL usernames and passwords. The course is approved for 4.50 contact hours through the Iowa Board of Nursing. Discounts are available for group/team registrations when registering five or more individuals by following these <u>group registration instructions</u>.

### **Protecting Rural Seniors' Access to Care Act**

Over 500 national associations, state organizations, and providers including ND Long Term Care Association signed a letter in support of the Protecting Rural Seniors' Access to Care Act -- and the anticipated House Ways and Means Committee mark-up of this bill that would prohibit the U.S. Department of Health and Human Services Secretary from finalizing the proposed nursing home staffing rule. The bill would also establish an advisory panel on nursing home staffing. We received word that the Committee will likely be considering the bill, with a date TBD (we will share details as we have them).

## CMS Releases Medicare Advantage RFI and CY25 Advance Notice

#### Train More Nurses Act Passed in the U.S. Senate

The <u>Train More Nurses Act</u> (S. 2853), <u>introduced last year</u> by Senators Jacky Rosen (D-NV), Mike Braun (R-IN), and Susan Collins (R-ME), was agreed to unanimously by the U.S. Senate on January 24, 2024. It will move next to the U.S. House of Representatives for consideration.

This bipartisan bill, which AHCA/NCAL supports, directs the Secretary of Health and Human Services and the Secretary of Labor to conduct a review of all nursing grant programs to find ways to increase faculty at nursing schools, particularly in underserved areas. It also increases pathways for Licensed Practical Nurses to become Registered Nurses. AHCA/NCAL backs efforts and policies like this one to help address the nursing shortages impacting long term care.

## What to Know About the Independent Contractors Final Rule

What to Know About the Independent Contractors Final Rule
Last month, the U.S. Department of Labor published a final rule, entitled
Employee or Independent Contractor Classification Under the Fair Labor
Standards Act, which goes into effect on March 11, 2024. This rule revises the
Department's guidance on how the agency determines who is an employee or
independent contractor under the Fair Labor Standards Act (FLSA). It
specifically rescinds the Independent Contractor Status Under the Fair Labor
Standards Act rule (2021 IC Rule), that was published on January 7, 2021,
under the Trump Administration, and essentially reverts to the agency's earlier

and broader multi-factor economic realities test.

The new standard will, in certain circumstances, make it more difficult for long term care providers to properly classify a worker as an independent contractor. Likewise, this final rule has the potential to place greater financial and legal burdens on long term care providers as existing contract workers may now need to be reclassified as employees under the new standards.
