

# Interim Health Care Committee and Contract Nursing

As mentioned before, the members' Resident Issues Committee came together to discuss the contract nursing study within the interim Health Care Committee. The Resident Issues Committee felt it would be beneficial to consider licensing and putting minimum standards on contract agencies. We reviewed and discussed a 2015 bill that had been introduced. This was presented to the interim Health Care Committee by Nikki on January 30th and DTN Staffing provided a presentation that followed. The interim committee stated that they would like us to continue working on this, expand our committee to other stakeholders, and bring back a report. ### WelcomeCorps at Work: Welcoming refugee talent

Welcome Corps at Work, is a program that matches employers in this country with skilled refugees in need of resettlement and enables refugees and their immediate families to relocate permanently to the United States. This program seeks to provide a sustainable, scalable solution to workforce and skills shortages among U.S. employers at absolutely no cost to the employers. This is a U.S. State Department program and the International Rescue Committee (IRC) and Talent Beyond Boundaries (TBB) are working closely with the Bureau of Population, Refugees and Migration on each component. Currently, they are engaged with over 2,500 individuals seeking work as part of the program.
