

## **ND HHS Update**

### **CNA Certification and Registration Changes**

Released Feb. 21, 2024

Federal requirements do not allow an individual to challenge a CNA exam or to take the exam without having completed a nurse aide training and competency evaluation program (NATCEP).

Effective July 1, 2024, all individuals seeking to become a CNA will be required to complete a state-approved nurse aide training and competency evaluation program before completing the exam.

In addition, the North Dakota Nurse Aide Registry is changing the process for determining expiration dates of CNA registrations. Expiration dates will be based on the date of initial registration plus two years with a renewal on a 2-year timeframe. Currently, expiration dates are based on the last date worked plus two years. Expiration dates will no longer be based on the last date worked.





## **NCAL Update**

#### Medicaid Access Rule Under Review at OMB

The <u>CMS Medicaid Access Proposed Rule</u>, which includes home and community based services (HCBS) mandatory quality measures, is now under review of the Office of Management and Budget (OMB). This proposal has a requirement that providers allot 80% of their HCBS payments to direct care workers, among other things. OMB will review the regulation and determine the cost to the government to implement the rule as proposed; this is one of the final steps prior to the final rule being released.

NCAL along with over 2000 associations, providers, and other stakeholders submitted comments in response to the proposed rule last summer. The overarching theme of our comments are:

- NCAL does not support the proposal that CMS mandate any pre-set percentage of waiver service reimbursement to direct care givers without evaluation of the adequacy of HCBS waiver rates in all 50 States and the District of Columbia.
- NCAL recommends CMS conduct a study to identify the impact of the proposed rule and unintended consequences.
