


## **Quality Incentive Program Update**

# Senators Cramer and King Introduce Bipartisan Legislation to Protect Veterans' Long-Term Care

U.S. Senators Kevin Cramer (R-ND) and Angus King (I-ME), members of the Senate Veterans' Affairs Committee, introduced a piece of legislation which would require the U.S. Department of Veterans Affairs (VA) to conduct a study examining the risks associated with the proposed minimum staffing rule issued by CMS. This follows the letter Senators Cramer and King sent to CMS Administrator Chiquita Brooks-LaSure asking the agency to withhold from establishing staffing mandates for long-term care facilities and instead work with

Congress on flexible, commonsense solutions.

## **Protecting Rural Seniors' Access to Care Act**

ALL MEMBERS

The Protecting Rural Seniors' Access to Care Act (S. 3410/H.R. 5796), would prohibit the U.S. Department of Health and Human Services (HHS) Secretary from finalizing the proposed nursing home staffing rule. The legislation would also establish an advisory panel on nursing home staffing. It would include voices from both urban and rural communities and range from nurses to licensed administrators to CMS. Within 60 days following their initial meeting, the panel would submit a report to Congress that analyzes workforce shortages and makes recommendations to strengthen the workforce (including investments in training for health professionals). AHCA/NCAL submitted a letter including support from 1,100 national and state associations and provider organizations.
