ND HHS Update

High Efficiency Particulate Air (HEPA) Enhancement Program

All Members

The North Dakota Department of Health and Human Services (NDHHS) is announcing the availability of new funding for HEPA air-cleaning device(s) and/or filters. This program is intended to reimburse facilities who purchase HEPA devices and/or filters that improve the air quality in resident rooms and/or gathering areas. This one-time funding is available for Congregate facilities that provide basic care, independent living, assisted living, skilled nursing, and other care listed in this survey are eligible for this funding.

Allowable purchases made on or after **January 1**, **2024 through April 19**, **2024** will be reimbursed **up to \$5,000** per individual facility location.

ICAR Visit - Nonregulatory

Have you had an ICAR Visit? Check into it!

An Infection Control Assessment and Response (ICAR) is when someone with specialized training visits your facility and works one-on-one with your team. An (ICAR) tool is used to guide the visit to assess infection control & prevention practices and guide quality improvement activities. It is non-regulatory. An opportunity to prepare for surveys. Feedback and infection control training are also provided.

We extend our sincere appreciation once more to Maren Gemar from SMP Health - St. Raphael and Reier Thompson from Missouri Slope Lutheran Care Center for graciously stepping forward to address the committee on the challenges surrounding behavioral health in long-term care settings. Their insights illuminated the formidable barriers posed by federal regulations, underscoring the urgent necessity for a responsive system to address behavioral health crises promptly.

Pam Sagness with the Behavioral Health Division, provided an update on behalf of the collaborative efforts cohosted by NDLTCA and the ND Hospital Association. This ongoing collaboration aims to gather data and identify solutions across the continuum of care.

Karla Backman, the State Ombudsman, also commented on the challenges faced by skilled nursing facilities, emphasizing their impact on residents and their families. She reiterated the critical importance of establishing a responsive behavioral health system capable of quickly addressing crises as they arise.


