






Regions 3 and 5

Keep It Local Healthcare Talking Points

All Members

Keep it Local is a statewide coalition against Measure 4 which seeks to abolish property tax in North Dakota. The coalition is an ideologically broad group with a central goal of maintaining local control and keeping our communities' great places to live. Here are some talking points for educating and informing your

community members, as a community member:

REDUCED ACCESS TO HEALTH CARE SERVICES: State budgeting changes to backfill property taxes may lead to cuts to the ND Dept. of Health and Human Services budget (the largest in the state) and reimbursements to health care providers, **decreasing access to healthcare services for patients and their families.**

SOCIAL DETERMINANTS OF HEALTH: Community partners that provide critically important services to support well-being – public health, public transportation, social services – **may be negatively impacted and forced to reduce community services.**

WORKFORCE: The essential local services that property taxes fund will be threatened, **decreasing quality of life in our communities**, negatively impacting our ability to recruit and retain workforce throughout the state.

AHCA/NCAL Updates

Access to Nursing Home Care is Worsening

The American Health Care Association and National Center for Assisted Living (AHCA/NCAL), representing more than 14,000 nursing homes and other long term care facilities across the country that provide care to approximately five million people each year, today released updated data demonstrating a worsening access to care crisis impacting seniors and individuals with disabilities in need of long term and post-acute care.

The <u>2024 Access to Care report</u> highlights the intense economic and government pressures providers have faced since the pandemic, resulting in fewer care options and delays in care for our nation's most vulnerable. Specifically, the report looks at the cumulative effect of continued nationwide

labor shortages, record inflation and increasing operational costs, and chronic government underfunding. These recent challenges have severely impacted seniors' ability to access skilled care as nursing homes are forced to limit admissions, downsize, or close altogether.

Frontline Caregiver: CARES® Serious Mental Illness (SMI) Training and Certification

The CARES® Serious Mental Illness™ Training Program focuses on how you can develop care strategies for those with serious mental illness and how it differs from dementia.

For many years, the centers for Medicare and Medicaid services have led a national effort to reduce the use of antipsychotic medications, especially for people living with dementia. But there are appropriate uses of antipsychotics. By definition, they are designed to help people with serious mental illnesses such as major depression, schizophrenia, bipolar disorder, and schizoaffective disorder. This program does a deep dive into each of these illnesses and provides helpful strategies for caring for people living with a serious mental illness who may be in your care. This program has 4 modules (4 hours) which includes: Introduction to Serious Mental Illness, Understanding Serious Mental Illness, Living with Serious Mental Illness and The CARES® Approach and Providing Appropriate Care. This is a 4-part session that will provide a certification in CARES SMI upon completion and successful passing of the certification exam.

Global Talent Summit-Office of Legal Immigration

Nikki and Mandy Robinson, one of the chairs for our new NDLTCA Workforce Committee participated in the Global Talent Summit last week, hosted by the Department of Commerce. The summit provided valuable insights into programs available for our members, including efficient visa pathways like the E3 Visa for Australians. This visa allows us to fill nursing positions without language barriers and also permits spouses to work on their trailing visas. Additionally, the E3 Visa has a cap that is rarely reached.

Paige Kuntz from the Office of Legal Immigration is arranging a virtual meeting with a recruiter for our members to discuss these opportunities further—stay tuned for details!

Another visa option highlighted was the TN Visa under the NAFTA agreement for Canada and Mexico. This visa is particularly advantageous as it does not require petitions and is not subject to numerical caps.
