Human Services Committee Update

NF and Geropsych

On September 25, 2024, Nikki testified before the interim Human Services Committee about key challenges in long-term care, especially for residents with psychiatric needs. She highlighted workforce shortages, unsustainable reimbursement rates, rising behavioral health demands, and limited access to acute psychiatric care. Proposed solutions include improved funding, specialized training, expanded geropsychiatric services, and better crisis intervention resources to support residents and caregivers in these facilities. <u>Watch the recording here...</u>

Attendees expressed significant concern over the proposal to streamline basic care, assisted living, and specialized basic care into a single licensing structure. This shift would require compliance with the Home and Community-Based Services (HCBS) Settings Rule, which restricts basic care and assisted living facilities from being co-located with nursing facilities or hospitals. Our analysis suggests that this change could potentially impact and displace 230 basic care residents and 293 assisted living residents across the state.

Another significant concern was the recommendation to improve regulation and survey oversight for basic care and introduce it assisted living facilities. Currently, basic cares are surveyed infrequently, and assisted living facilities are not subject to regulation in North Dakota. Many attendees felt that increased oversight might not align with the nature of assisted living, where tenants are often independent and choose to live there out of convenience rather than necessity. Assisted living is private pay, and residents have the freedom to move elsewhere if desired. Given that both of these are lower levels of care, there is apprehension that new regulations could impose unnecessary constraints on a system that is working well for many residents without heavy oversight.

NDLTCA waited for the Guidehouse report in the hopes that it would address the current basic care payment system that would be funded during the 2025-2027 biennium. Since the report did not address some of the more basic reimbursement mechanisms, our membership will meet to address our positions. With regard to changes in the basic care reimbursement system, there a few issues that need to be addressed in the next legislative session; Continue recalculation every year and rebase the limits every 4 years, explore a property system that can reimburse facilities in excess of their costs, and a true annual inflator on our prior allowable costs.

We will be presenting our comments at the Health Care Committee meeting tomorrow, followed by a meeting with Sarah Aker and her team to voice our concerns. Both Sarah and Commissioner Salter have expressed their commitment to working collaboratively with NDLTCA and our providers. Your continued engagement is crucial as we navigate the legislative session. We'll need your input and support to ensure all your needs are addressed in the coming months.

Nursing Facility Incentive Payment Program Update



Several members involved in the development of the Nursing Facility Incentive Program (NFIP) recently met with Sarah Berreth and LeeAnn Thiel to review the program's success in its first year and explore potential enhancements. After a productive discussion, the following changes were agreed upon:

- Regarding serious mental illness (SMI)
 - Facilities with >=30% SMI diagnoses will get an additional 30 points rather than 20. These points will be added to their antipsychotic quality measure points.
 - Sarah Berreth and this group will monitor the effect of >=30% SMI on NFIP at least annually.
- Fund Distribution
 - Use a weighted distribution of 100%, 85% and 60% to distribute all funds to Tiers 1, 2 and
 3 respectively resulting in no redistribution of funds in a second cycle.

Senator Cramer Delivers Floor Speech on Unworkable Nursing Home Rules, Bureaucratic Intransigence at CMS

U.S. Senator Kevin Cramer (R-ND) spoke on the Senate floor last Tuesday, criticizing the new federal minimum staffing rule for nursing homes. He argued that the mandate would worsen staffing shortages, limit access to care, and could result in more nursing home closures, particularly in rural areas. 

USCIS Reaches H-2B Cap for First Half of Fiscal Year 2025

On September 19, the U.S. Citizenship and Immigration Services (USCIS) <u>announced</u> that it has reached the congressionally mandated cap on H-2B visas for temporary nonagricultural workers for the first half of fiscal year 2025.September 18 was the final date for new cap-subject H-2B petitions requesting an employment start date before April 1, 2025.
