### **NDLTCA Update**



#### **Voting Starts Next Week!**

All Members

With absentee voting beginning next week, please prioritize sharing clear, concise information about the measure's impact, the voting process and how your community can participate. This is a pivotal moment, and your proactive efforts will help maximize voter turnout and support for our shared goal.

This measure would eliminate property taxes and prevent cities, counties, townships, and schools from taxing property based on its value. It was introduced through a citizen-led initiative to amend the state constitution. Property taxes currently fund local services like schools, police, fire, road maintenance, and parks. The measure would require the state to replace the lost revenue, but only up to the 2024 tax levels, resulting in an estimated \$1.329 billion annual

shortfall. The Legislature would have to find a way to cover the gap, likely leading to cuts in programs, specifically Medicaid, which is one of the largest of the Health and Human Services budget. A YES vote removes property taxes and leaves the state responsible for replacing the funds, likely leading to Medicaid cuts. A NO vote keeps the current system, allowing local governments to continue levying property taxes for essential services.

#### Guidehouse's BC/AL Study Recommendations

AL and BC

The ND Department of Health and Human Services has yet to share the report or presentation with providers or NDLTCA. Last week, they presented a PowerPoint, and we've requested both the slides and the report, which they said would be available this week and posted online. We have some concerns based on the presentation, particularly around combining licensure for BC, AL, and Specialized BC, and the possibility that these services may need to comply with the HCBS settings rule. If BC and AL can no longer be co-located with nursing facilities, this could pose significant challenges, especially for rural facilities.

With the \$5 BC add-on ending this year and the study showing that BC rates still don't fully cover care costs, the issue of payment remains unresolved. We had hoped for a more collaborative

process, similar to how the NF payment system was handled, but it has been difficult to even access the report thus far.

Earlier this year, we shared our concerns about the study with Commissioner Salter, and he reassured us we'd have an opportunity to provide input after its release. Now that the study is out, we aim to meet with DHHS to understand the findings and address payment concerns.

While we had hoped to resolve these issues before the legislative session, the timeline may not allow for that. If DHHS can't address this now, we may need to consider requesting gap funding and plan to meet in May 2025 to continue discussions.

#### LTC Advisory Committee - September 13

The Long Term Care (LTC) Advisory Committee is a collaboration between the state, LTC providers, and other stakeholders. The purpose is to provide a forum for LTC providers to discuss statewide issues with state agencies, learn about industry updates, and communicate concerns to the public, media, legislators, and other stakeholders. It supplements but does not replace the annual Medicare/Medicaid survey process for individual facilities.
