# Republicans Lefor, Hogue to again lead during 2025 legislative session

BISMARCK — House Majority Leader Mike Lefor and Senate Majority Leader David Hogue will keep their leadership positions during the 2025 legislative session.

Lefor, R-Dickinson, was challenged by Rep. Ben Koppelman, R-West Fargo, while Hogue, R-Minot, ran unopposed. They were reelected during the closed Republican caucus meetings Tuesday, Nov. 12, in Bismarck.

Assistant House Majority Leader Rep. Glenn Bosch, R-Bismarck, was reelected, and Rep. Jeremy Olson, R-Arnegard, was elected majority caucus leader. Rep. Robin Weisz, R-Hurdsfield, was elected House speaker.

Sen. Jerry Klein, R-Fessenden, was reelected assistant majority leader in the Senate. The Senate also kept Sen. Kristin Roers, R-Fargo, as majority caucus leader.

House and Senate minority leaders will be elected during the Democratic caucus meetings in the coming weeks.

Rep. Zach Itsa, D-Grand Forks, led the party as House minority leader during the 2023 sessions, and Sen. Kathy Hogan, D-Fargo, was the Senate Minority Leader.

Republicans maintain a supermajority with 42 members in the Senate to five Democrats and 83 Republicans to 11 Democrats in the House, according to unofficial election results.

# NCAL Continues Advocacy for the Expanding Veterans' Options for Long Term Care Act

The National Center for Assisted Living (NCAL), along with other organizations advocating for older adults, sent collectively this week a <u>coalition letter</u> to the U.S. House VA Committee Chair and Ranking Member along with House Leadership. The letter encourages support during this lame duck session for movement of <u>H.R. 8371</u>, the <u>Senator Elizabeth Dole 21st Century</u> <u>Veterans Healthcare and Benefits Improvement Act</u>. This comprehensive bill includes a scaled back version of <u>H.R. 1815</u>, the <u>Expanding Veterans' Options for Long Term Care Act</u>. This is legislation NCAL endorses that creates a pilot program for eligible veterans to receive AL care paid for by the VA. We have advocated for H.R. 1815 during previous AHCA/NCAL Congressional Briefing fly-in events. NCAL will keep its membership apprised of any potential developments.

# Skilled Nursing Facility Quality Reporting Program (SNF QRP)

SNF

Recently, we are hearing of increased concerns for facilities meeting MDS reporting requirements, in particular to GG0130E, Shower/bathe self. Facilities are noting decreased compliance rates due to dashing this item, due to CMS guidance.

- If the resident did not receive a bath/shower because the resident did not attempt the activity and a helper does not complete the activity for the resident during the entire assessment period, GG0130E: Shower/bathe self would be coded with one of the "activity not attempted" codes (07, 09, 10, or 88).
- If the resident did not receive a bath/shower because they were not scheduled for one during the entire assessment period, the assessment did not occur and GG0130E:
   Shower/bathe self would be coded with a dash (-).
- A dash value indicates that the data element was not assessed and therefore no information is available.

### **DOL Overtime Rule Struck Down**

Last Friday, a federal judge in Texas struck down the "Overtime Rule" from President Joe Biden's Administration/the U.S. Department of Labor (DOL) that would raise the minimum salary threshold for employees who are classified as "exempt" from payment of overtime wages under the white-collar exemptions to the Fair Labor Standards Act. Under this DOL rule, the salary threshold requirements for employees to be classified as "exempt" under the "white collar" exemptions increased in stages, with the first one that went into effect on July 1, 2024. The next increase was scheduled for January 1, 2025. Click here for the AHCA/NCAL analysis on the rule for your reference (second rule listed on the attached). The Admin/DOL could possibly appeal and try to get the rule reinstated in these few remaining weeks, but the Trump administration would likely not be in favor of such an appeal.
